- been in STM since 3/22/19 - had an argument w/ female officer Ms [redacted] in 7N

- was in b tier, J tier, K tier, M tier, L tier now in H tier (for 3-4 weeks); was in M tier 21 months, was in K tier 20 days before that, J before that

- march J tier
- M tier
- K tier
- b tier - was there 2 mos ago
- H tier

JE asked Lt. [redacted] when can I leave the box. Lt. [redacted] (m) said we need to keep you secure. in case ppl try to extort you.

- met Epstein in b tier. Met when he came back from suicide watch. Dlu have bunkye. He was in b tier 1 night. Before JE left, they brought him out + made sad eyes. (JE)

- saw him in L tier when took shower - his cell was next to shower.

- CS6 was working and took copy of JE ID on the door took it after he died

- on August 9 - CS6 birthday - was in lawyer visit, JE was speaking w/ woman attorney (black hair, light skin), face was red + looked mad

- on the way on the elevator, CS6 told guards "you better take that man out of there or he's going to kill himself"

↳ said to brijalva + Monge said in English

(monge) s/s  
↳ their answer was "he's going to kill himself no matter what and he's gotta pay for what he did, he's going to kill himself any way b/c he can put up w/ pressure. we don't care either way. let him kill himself."

- CS6 had heard comments that VE had tried to hang himself before.
- VE seemed desperate that day
- saw VE ~3 times before that
- on Aug 9, fan was on. They dln do the 10pm count. went to sleep 3/4 am. boards dln do count the whole time. was listening to music w/ one headphone in. in 2nd cell on left hand side. can see highway from window.
- don't usually leave fan on. put fan on when inmates start making noise.
- the next morning at breakfast time there was a Lt. going out breakfast. ms. Anderson
- guards do count ~~at 10pm - mandatory~~ at 10pm - mandatory. Some dln do 1, 2, 3, 5 rounds, others don't. Some guards do 30 min rounds, others don't.
- took system's ID thinking about money but then this situation came up.  
↓ was cleaning when took it.  
took it 1+1/2 wks after he died.
- ↓ dln know names of guards who don't do overnight counts.  
different guards.
